<u>Background</u>: Due to an overwhelming demand for Microenterprise Grant Program funding, Chippewa County is in the process of securing additional Community Development Block Grant (CDBG) Coronavirus (CV) funds from the Wisconsin Department of Administration so that assistance can be provided to all eligible businesses submitting applications. These additional funds will result in increased administrative requirements and staffing costs. An amendment to the financial payment section of the previously signed agreement is therefore being presented.

<u>Potential Action</u>: Review and approve amendment to the Microenterprise Grant Program administrative services agreement between Chippewa County and WCWRPC.

8. Approval of Entering into a Memorandum of Understanding with the Wisconsin Economic Development Corporation (WEDC) for Administration of the Wisconsin Tomorrow Main Street Bounceback Program – LeMahieu/Nelson/Frank

<u>Background:</u> WCWRPC has been approached by WEDC to administer the Wisconsin Tomorrow Main Street Bounceback Program for west central Wisconsin. Staff will provide an overview of the program and required administration.
